 - o Card room open for this activity week days from 5p.m. to 7p.m.
 - Weekends, available until guards' closing at 11p.m.
 - o Arts and crafts room available until guards' closing at 11p.m.
 - o If either room is already occupied, those residents have preference
 - Observe maximum capacity of each room
 - o Occupancy of both rooms open to all residents
 - o Shut off lights and fans when leaving
 - o Kitchen remains closed
