### **NEW BUSINESS:**

- Motion to approve the proposal from Mike Pacheco Lawn Service for the West Walkway project at a cost of \$13,000. This project includes the removal of all firebush plants and adding sod to those areas. A motion was made by Dennis Prisant and seconded by Paul Negron. Esther Bean opposed. Motion passed 5-1.
- Motion to replace the wood ramp to the shed with a Trex Deck ramp, at the cost of \$1,368.81, with an added contingency of approximately 10%, bringing the total to \$1,500.00. A motion was made by Paul Negron and seconded by Noel Franco. Motion passed unanimously.
- Motion to approve a change for Clubhouse Rule # 6, so that it will now state: Food and Beverages are not permitted in the Clubhouse, except for plastic bottled water or for special sanctioned events or functions. An additional exception shall allow food and beverages to be consumed in the Arts and Crafts Room when that room is not being used for scheduled events. A motion was made by Esther Bean and seconded by Dennis Prisant. Paul Negron opposed. Motion passed 5-1.
